Plaintiff files the Post Judgment Interrogatories in the Clerk's Office of the Fulton County Magistrate Court. The cost varies according to when the interrogatories are filed. If the Interrogatories are not answered within 30 days from the date of service, the judgment creditor may file a Motion to Compel Answers to Post Judgment Interrogatories together with a notice of hearing.
