The elements of medical negligence are (1) duty, (2) breach, (3) injury, and (4) proximate causation. As discussed by the Court in the case of Noel Campang v. Nelson Cortejo, duty refers to the standard of behavior that imposes restrictions on one's conduct. It requires proof of a professional relationship between the physician and the patient.

1. CODE OF ETHICS OF THE PHILIPPINE MEDICAL ASSOCIATION. ARTICLE 1 GENERAL PRINCIPLES Section 1. The primary objective of the practice of medicine is service to mankind irrespective of race, age, disease, disability, gender, sexual orientation, social standing, creed or political affiliation. In medical practice, reward or financial gain should be a subordinate consideration.
