Psychological theories of crime also focus on the individual as the unit of analysis. Specifically, the mental processes of the individual are examined for anomalies that might contribute to criminal behavior. As with the biological theories, direct causal pathways have not been established (Akers 1994, Hagan 1990, Siegel 1992).
