Medicare Part B (Medical Insurance) for longer than 12 months, you can get a yearly “Wellness” visit once every 12 months to develop or update a personalized prevention plan to help prevent disease and disability, based on your current health and risk factors. Your provider may also perform a cognitive impairment assessment.

No. However, Medicare does cover an annual wellness visit. An annual wellness visit is not a physical, but it does include a review of your basic health measurements (e.g., height, weight, blood pressure, etc.) and your medical history. The doctor also reviews your risk factors for certain other diseases and conditions, and develops a personalized plan for prevention services.

Does Medicare pay for a yearly physical examination?

Together with your primary healthcare provider, you should sit down and discuss your physical examination schedule. Medicare offers an initial health exam when you are first enrolled in Medicare coverage and annual health care visits. If you are enrolled in Medicare Part B coverage, you will be eligible for an initial "Welcome to Medicare" visit.

In addition to these services, a typical annual physical might also include services such as a vital signs check, lung exam, head and neck exam, abdominal exam, neurological exam, and a check of your reflexes. Any blood work or lab tests that may be part of a physical exam, are also not included under a Medicare Annual Wellness Visit.

Medicare covers medically necessary blood tests ordered by a physician based on Medicare guidelines. Medicare Advantage (Part C) plans may cover more tests, depending on the plan.

What Blood Tests Are Covered by Medicare?

Check your height, weight, blood pressure, and other routine measurements. Give you a health risk assessment. This may include a questionnaire that you complete before or during the visit. The questionnaire asks about your health status, injury risks, behavioral risks, and urgent health needs.

G0402 is the “Welcome to Medicare Exam” which is basically a routine physical which can only be done in the first 12 months the patient becomes eligible for Medicare. G0438 is the code for the first, initial, Annual Wellness Visit.

Medicare does not cover an annual physical exam, as such. This may be confusing, so let’s look at what Medicare does cover. Welcome to Medicare Visit. Medicare Part B covers a Welcome to Medicare Visit. This visit is also called an Initial Preventive Physical Exam (IPPE).
